CIRCULAR LETTER TO ALL MEMBER COMPANIES

Re: New and Revised Commercial
Auto Coverage Forms

The North Carolina Commissioner of Insurance has approved for use on an optional basis by the member companies of the North Carolina Rate Bureau and the North Carolina Reinsurance Facility the Insurance Services Office (ISO) Commercial Auto Coverage Forms (Business Auto, Truckers, Motor Carrier and Garage Policies and endorsements for use in connection therewith).

ISO recently filed and received approval of numerous new and revised forms and endorsements. The forms, which are listed on the attached memorandum, have now been approved for use on an optional basis by the member companies of the Rate Bureau and the North Carolina Reinsurance Facility. Those forms which afford coverages not subject to the jurisdiction of the Rate Bureau or coverages not eligible for cession to the Reinsurance Facility were filed for informational purposes only.

The revised forms become effective in accordance with the following Rule of Application:

These changes are applicable to all policies effective on or after April 1, 1999.
