### <u>CIRCULAR LETTER TO ALL MEMBER COMPANIES</u>

### Workers Compensation Insurance

Re: Policy Reporting of Primary Names

The North Carolina Rate Bureau (NCRB) is updating the data reporting rules related to reporting of primary names. Currently, primary names are reported in a WCPOLS file with the name link 001 and the continuation sequence number 001. NCRB has determined a change is needed to eliminate the removal of the primary names from the policy when reporting in this manner results in corrupted policy data.

Under the new rules, when reporting changes for a policy on a policy replacement, the 02 - Name record must have a primary name that spans the entire length of the policy period. Primary names affected by policy changes are currently reported on different records and the change effective date and change expiration date are being applied to all records of the policy transaction.

The new data reporting rule will be effective May 1, 2017. Transactions reported with missing primary names will be rejected and fined until corrected. The error message that will be generated for incorrect reporting along with examples of how primary names should be reported are attached for your reference.
